## SECOND QUARTER 2009 RECAPS:

On **June 4, 2009**, there was a large attendance at the New York Chapter's annual Form 5500 presentation. **Louis F. LiBrandi**, a Director at McDermott Will and Emery provided a thorough and insightful presentation regarding the annual filing requirements for employee benefit plans.

The presentation provided practical tips regarding the preparation and processing of the Form 5500 and related schedules. In addition, the presentation covered many areas including: review of the new schedules SB and MB; responding to IRS and DOL notices; how to handle special filings for amended, final, or merged plans.

Also discussed were the filing changes scheduled to be implemented with the 2009 plan year filings, which require that the Form 5500 be filed electronically to the Employee Benefit Security Administration ("EBSA"). This change is required pursuant to the DOL's regulations issued in November 2007. The DOL has indicated there will be faster processing of filings and an immediate notification if a filing contains a deficiency (error or omission). In addition, a new FORM 5500-SF will be available, Schedule E will be eliminated, and the Schedule SSA will be converted to Form 8955 and be filed directly to the IRS. The IRS will not require filings in electronic format.

On **May 14, 2009**, a one-day Health & Welfare Fundamentals program was held at the American Management Association. Approximately 30 people attended the workshop and gained valuable knowledge from the selection of speakers and topics:

- **Anthony Rienzi** from Buck Consultants spoke about medical plan designs and current developments in the health care industry.
- **Len Comberiate** from The Great Atlantic & Pacific Tea Company presented information on flexible benefit plan arrangements.
- **William Duff** from Katten Muchin Rosenman LLP conveyed legislative updates and compliance issues.
- **Eric Hamilton** and **Anne Albrecht** from Guardian presented on life, dental, and disability plans.

Participants said they enjoyed the program and that they will be able to apply their new knowledge to their jobs.

The CEBS Fundamentals programs are designed for recent entrants to the employee benefits field and more experienced benefits professionals seeking to reinforce their skills and keep up with the ever-changing benefits environment.

The Pension Fundamentals program is scheduled for October 22, 2009. Additional information to follow.
